

LIST of FEUARS in DUNSHOLT who claim to be entitled to the servitude or privilege of a bleaching green upon the north side of the Water of Eden above the Bridge in Dunsholt, and who were involved in an action in the Court of Session commenced on 8th August, 1927, at the instance of Mrs. Janet Barr or Thomson, wife of John Malcolm Thomson, Ramsay Lodge, 1 Russell Place, Trinity, Leith, against Ebenezer Laing, Alexander Duncan, Frederick Philp, Robert Ewing, John Allan, William Christie and Andrew Moodie, as proprietors of certain pieces of land in Dunsholt for declarator and interdict. Said action was settled on the Pursuer agreeing to pay a yearly sum of £1:10/- to the Defenders and their successors at Whitsunday yearly and on the Pursuer recognising the right of the whole inhabitants of the Village of Dunsholt to the use of the road or path called the Ford Road to the River Eden running off from the main highway (Auchtermuchty to Falkland) to the edge of the River Eden between the Old Schoolhouse and the Bridge over the Eden for the purpose of drawing water and watering beasts and other usual similar purposes conform to use and wont.
